A motion was made that we instruct Stu Seibold to remove all traces of the proposed ordinance from the Act 537 plan and after all traces have been removed of the proposed ordinance from the plan then have Mr. Seibold or Nancy resubmit the plan to DEP as soon as possible; Gutheil/Smithgall. Motion carried.
